

LOGIN PROCESS


After successful registration you can login to this web site and start using its all features. For login you have to follow the procedure given bellow:



This section is divided into following two parts.

DIGEST

This part shows results court wise with a count, fetched from searching in only head notes. You can uncheck the box in front of a result to exclude it from results shown in adjacent section.

JUDGMENTS

This part shows results court wise with a count, fetched from searching in full judgment text. You can uncheck the box in front of a result to exclude it from results shown in adjacent section.

You can also hide/show this entire section whenever required.




